Announcement Re: Acquisition of Shares in Inci Aku Sanayi ve Ticaret Anonim Sirketi in Republic of Turkey

Our consolidated subsidiary GS Yuasa International Ltd. (President: Makoto Yoda, Principal Office: Minami-ku, Kyoto. hereinafter referred to as "GS Yuasa") has decided to acquire 50% of the issued outstanding shares in Inci Aku Sanayi ve Ticaret Anonim Sirketi (hereinafter referred to as "Inci") in the Republic of Turkey (hereinafter referred to as "Turkey") which is engaged in manufacture/sale of the lead-acid battery for automotive, forklift and stationary applications and entered into an agreement for the share transfer with the existing shareholders including Inci Holding Anonim Sirketi (hereinafter referred to as "IHD") as of today. We hereby announce this as stated below:

Statement

1. Reason for Acquisition of Shares

Declaring "Global Expansion based upon Overseas Growing Markets as the Pivots" as an important strategic challenge in the third mid-term business plan, our group is on the progress in expanding our business and enhancing earning capacity.

This time, we have resolved to have Inci as our equity method affiliated company, with a view to turning it into one of our key centers in the global strategy, by acquiring 50% of the issued outstanding shares from the existing shareholders.

Inci is a manufacturer engaged in the manufacturing and selling of the lead-acid storage battery for automotive, forklift and stationary applications, with its turnovers being in the second place in Turkey. Capitalizing on the location where it stands as a geographical advantage, this manufacturing company makes its turnovers, over the half of which are through its export to destinations the world over, in more than 80 countries including its neighbors.

We are aiming, as a target of our group, to realize our sales expansion domestically in Turkey where there continues to be a steady increase in demand for lead-acid storage batteries and also further scale-up of our existing exports to regions including Europe, Asia, the Middle East and North Africa; as part of our global strategy, we are committed to pursue a large expansion of our lead-acid storage battery business in the above-mentioned regions, in which we have not been very competitive thus far.

Additionally, we plan to change the trade name of Inci to "Inci GS Yuasa Anonim Sirketi" later this year, expectedly in August.
